BEING AWARE THAT, WITH A DELIBERATION OF THE MUNICIPAL COUNCIL, GENERAL PROTOCOL NO. 47/2017, THE MUNICIPALITY OF GRADO INTRODUCED AND REGULATED THE TOURIST TAX UNDER ART. 4 OF THE LEGISLATIVE DECREE NO. 23/2011;

BEING AWARE THAT, UNDER ART. 9 OF THE REGULATIONS OF THE TOURIST TAX, APPROVED WITH THE ABOVE MENTIONED DELIBERATION, IN CASE OF NON-PAYMENT, DELAYED PAYMENT OR PARTIAL PAYMENT OF THE TAX, A TAX SANCTION WILL BE APPLIED, AMOUNTING TO 30% OF THE UNPAID TAX, AND THAT, IN THIS CASE, THE FISCAL AND CONTRIBUTORY POSITION OF THE TAXABLE PERSON WILL BE SUBJECT TO AN IMMEDIATE CONTROL (WITH THE COLLABORATION OF THE REVENUE AGENCY AND THE FINANCIAL POLICE), AS PART OF THE ACTIVITY OF THE MUNICIPALITY IN THE FIGHT AGAINST TAX FRAUD AND CONTRIBUTORY FRAUD;

DECLARES THAT

- HE OR SHE STAYED IN THE ACCOMMODATION FACILITY _____ ADDRESS _____ FROM _____ TO _____;
- THAT HE OR SHE WAS INFORMED BY THE MANAGER OF THE ACCOMMODATION FACILITY DESCRIBED ABOVE OF THE OBLIGATION TO PAY THE TOURIST TAX;
- THAT HE OR SHE REFUSED TO PAY THE TOURIST TAX TO THE MANAGER OF THE ACCOMMODATION FACILITY, AMOUNTING TO € _____, CALCULATED ACCORDING TO THE RATES SET BY THE MUNICIPALITY OF GRADO;
- THAT THE REASONS WHY HE OR SHE DID NOT PAY THE TOURIST TAX ARE THE FOLLOWING (indicating the reasons why a person did not pay the tourist tax is optional);
